AB341

MANDATORY COMMERCIAL RECYCLING REQUIREMENTS. A business (includes public entities) that generates four cubic yards or more of commercial solid waste per week or is a multifamily residential dwelling of five units or more shall arrange for recycling services. Businesses can take one or any combination of the following in order to reuse, recycle, compost or otherwise divert solid waste from disposal:



- Self-haul.
- Subscribe to a hauler(s).
- Arrange for the pickup of recyclable materials through Mission Trail Waste Systems.

Subscribe to a recycling service that may include mixed waste processing that yields diversion results comparable to source separation.
