AB341– Mandatory Commercial Recycling Requirements

A business (includes public entities) that generates 4 cubic yards or more of commercial waste per week or is a multifamily residential dwelling of five units or more shall arrange for recycling services. Businesses can partake in one or both of the following, in order to divert what otherwise would be disposal/landfill.

- Self-haul
- Arrange for the pickup of recyclable materials through Mission Trail Waste Systems.

AB 1826—Mandatory Commercial Organics Recycling Requirements

This Assembly Bill requires businesses generating 4 cubic yards of trash per week create an organic waste recycling program, including multifamily residential dwellings consisting of five or more units. Organic waste means food waste, green waste, nonhazardous wood waste, landscape and pruning waste.

• Use your green bin to get the organic material out of your recycling bin and trash bin.

Best Diversion Practices

- If your business is generating coffee grounds and wet organic material (food scraps, employee lunches & yard clippings), please place these materials in the green organic container.
- Please advise employees all recycling material should be dry and clean before discarding in your blue container.
- All cans, glass, plastic bottles, paper and cardboard is to be placed in your blue recycle bin.

CARDBOARD REMINDERS

Flatten and/or cut your boxes to make as much room as possible in your Recycle bin. Place shredded paper inside a paper bag to prevent flyaways.

Have extra recycle?

Cut and bundle your extra cardboard down to a size that will fit directly inside the recycle bin. Our Driver cannot reload the bin with cardboard that will not fit back in the bin.
